I need authorization to move \$230,000 from our General Fund to our CSD Reserve Savings account as a temporary fix to bring our General Fund to below \$250,000 FDIC limits so that our funds are protected in the event of a major financial crisis.

I had suggested to Director Deel that I would come up with a plan to present later in the summer and she suggested that we may want to take action sooner just to be safe, so this will be a temporary fix until I can determine whether it would be best to leave the funds in the savings account or establish an alternate plan to keep those funds protected.
