33033 Mountain View – 9 greenhouses, 2,833 MJ plants, 7 pounds of processed.

33287 Mountain View - 3 greenhouses, 200 MJ plants, 191 pounds of processed, 1 handgun and 1 arrest.

45583 Whetrock – 2 greenhouses, 411 MJ plants, 119 pounds processed.

34805 Newberry – 5 greenhouses, 644 MJ plants, 25 pounds processed and 1 arrest.

During this month, deputies handled 90 calls for service, took 17 reports, made 15 traffic stops and made 3 arrests in the unincorporated areas of Newberry Springs.

SUMMARY: Between January 10, 2022, and January 16, 2022, investigators from the San Bernardino County Sheriff's Department - Marijuana Enforcement Team (MET), along with San Bernardino Sheriff's deputies from several different Patrol Stations, served 18 search warrants at various locations in Lucerne Valley, Wonder Valley, Adelanto, Hesperia, Twentynine Palms, and Helendale. MET personnel had received numerous complaints about large outdoor and indoor marijuana cultivations in these areas. Over this past week, the San Bernardino County Sheriff's personnel located and arrested 15 suspects. Investigators seized 7,095 marijuana plants, 5,045.5 pounds of processed marijuana, 11 guns, 1,583 grams of concentrated marijuana, and over \$5,600.00 in cash. Investigators eradicated a total of 63 greenhouses found at these locations, as well as 2 THC extraction labs. Investigators located one live fragmentation hand grenade, which was destroyed in place by deputies from the Sheriff's Arson/Bomb Division.

The investigations revealed the cannabis cultivations were not in compliance with California's Medical and Adult-Use Cannabis Regulation and Safety Act (MAUCRSA) and San Bernardino County's ordinance prohibiting Commercial Cannabis Activity. San Bernardino County has a law prohibiting Commercial Cannabis Activity, which includes growing marijuana plants outdoors.

The Sheriff's Gangs/Narcotics Division will continue to enforce California's cannabis laws and San Bernardino County's ordinance regarding cannabis cultivation and distribution. Persons found guilty of violating the state law and county ordinance are subject to fines, prosecution, and seizure of property.

Property owners who are growing marijuana or are aware their tenants are growing marijuana on their properties in violation of the state law and local ordinances may also be subject to civil or criminal sanctions. Property owners are encouraged to contact their local law enforcement or code compliance agency to confirm if cultivating cannabis is prohibited or allowed under specific regulations.

SUMMARY: Between January 3, 2022, and January 9, 2022, investigators from the San Bernardino County Sheriff's Department - Marijuana Enforcement Team (MET), along with San Bernardino Sheriff's deputies from several different Patrol Stations, served 31 search warrants at various locations in Lucerne Valley, Morongo Valley, Yucca Valley, Adelanto, Hesperia, Pinon Hills, Phelan, Fontana, Victorville, Newberry Springs, El Mirage, Upland, and El Monte. MET personnel had received numerous complaints about large outdoor and indoor marijuana cultivations in these areas. Over this past week, the San Bernardino County Sheriff's personnel located and arrested 15 suspects. Investigators seized 12,370 marijuana plants, 3,361.7 pounds of processed marijuana, eight guns, 92.5 pounds of Psilocybin mushrooms, and over \$55,000.00 in cash. Investigators eradicated a total of 122 greenhouses found at these locations, as well as 12 indoor locations. Investigators mitigated one electrical bypass and recovered one stolen recreational vehicle.

The investigations revealed the cannabis cultivations were not in compliance with California's Medical and Adult-Use Cannabis Regulation and Safety Act (MAUCRSA) and San Bernardino County's ordinance prohibiting Commercial Cannabis Activity. San Bernardino County has a law prohibiting Commercial Cannabis Activity, which includes growing marijuana plants outdoors.

The Sheriff's Gangs/Narcotics Division will continue to enforce California's cannabis laws and San Bernardino County's ordinance regarding cannabis cultivation and distribution. Persons found guilty of violating the state law and county ordinance are subject to fines, prosecution, and seizure of property.
