

- *TRAINING IN HOUSE:
- (3) hours of training on: (with firefighters & Explorers) on the job training (911 calls for Fires) Rig check outs-maintenance from H&S Fire Apparatus Mobil service came in on Sun. 5/01/22 did a fleet inventory. We'll be setting up weekly maintenance until all apparatus' are up to DOT code & CHP inspection.
- *MUTUAL Fire Dept's TRAININGS: FTT 04/05/22 class time on "Ground Ladders" class was given by Yermo-Calico FD.
